MEMBERS BENEFITS

GRAVE:

- Graves are reserved at Izotsha Memorial Park for main members only
- Reservation certificate issued
- On claiming assistance, a grave numbered certificate is issued.
- Graves cannot be transferred from one person to another.
- Opening and closing of grave once (5 days' notice)
- Side-by-side grave (married society members) must be requested with first members deceased assistance. If not, another grave will be allocated.
- Should brickwork be requested (5 days' notice) bricks, mortar and labour are for own account.
- Permit fees are not waived should brickwork be requested.

DOVES: (6 Months' probation)

- 10 doves to be released on the day of the burial service at Izotsha Memorial Park.
- Should a member require additional doves discounted rates will apply.

FUNERAL SERVICE: Burial

This service is only for main members at Izotsha Memorial Park.

- Quarter view Casket,
- Collection/delivery of deceased 50km radius only,
- Storage, washing and preparing,
- Home affairs documentation,
- Coffin spray(flowers) 100 funeral programs,
- Hearse, family car,
- 2 pole tent/2 tables/100 chairs at home, lowering device/carpets/gazebo/ 10 chairs and 24 bottles water at grave
- R2000 Cash

CREMATION SERVICE PACKAGES

1. BASIC CREMATION SERVICE

- Collection within 50 km radius
- Completion of all documentation at Home Affairs
- Viewing at Undertaker's showroom

REPATRIATION:

This service is only for main members/spouse at Izotsha Memorial Park.

- Members that need to be repatriated from outside a 50km radius of Izotsha Memorial Park within the borders of South Africa only, are brought to the appointed Funeral parlour conducting the service. Covers members on short trips and visits less than 30days away from registered application address.
- Repatriation Assistance for one family member towards transport/accommodation should they need to identify the deceased society member,
- 51km to 100km R200.00,
- 101km to 200km R400.00,
- 201km to 400km R600.00,
- 401km to 600km R800.00,
- 601km and above R1000.00
- Maximum storage R1000.00 @ R200 per day
- Maximum total assistance per claim R10 000.00
- All arrangements must be kept with the appointed service provider.

CHILD ASSISTANCE: Grave, Tombstone & Burial membership at Izotsha Memorial Park

- Maximum of 5 children can be covered on a membership assistance plan (Grandchildren and registered foster children can be listed)
- Discounts can be arranged on behalf of members at relevant service providers.
- Stillborn R1000 cash
- 1 day to 5 Years R7000 cash
- 6 Years to 13 Years R14000 cash
- 14 Years to 21 Years R28000 cash

TOMBSTONE:

- Assistance in a form of a voucher for a tombstone to the value of the membership assistance plan taken to be used at Izotsha Memorial Park incorporating Granite crazy Tombstones.
- Includes 1st time installation, 1st time engraving.
- QR Code valid for 1 year, 2 minute maximum (reactivation yearly for a fee of R100.00)
- Members can request higher cover assistance for tombstone at an increased membership fee.

10% GROCERY BIRTHDAY MONTH CASH BENEFIT:

- Main members to receive 10% on all premiums paid yearly in their birthday month. It is the responsibility of members to ensure that the correct banking details and cell phone numbers are updated as the society will not be held responsible for any loss of payments or communications.

LEGAL ASSIST: (30 days probation)

- Nationwide Network of Attorneys, main members have telephonic/call back access to a Lawyer 24 hours a day.
- 30 min consultation per major case, access to essential documents portal, wills and testaments (A Must for every member) account disputes, judgements, employment disputes.
- Road accident fund claims and plenty other documentation via a client portal.

PROBATIONS: unless otherwise stated.

- On 2nd months society membership payment, member qualify for accidental deceased assistance and on 7th month society membership payment, member qualify for natural and accidental deceased assistance.
- On Membership AGE 85+ on 3rd months society membership payment, member qualify for accidental deceased assistance and on the 7th month membership payment, member qualify for accidental and natural deceased assistance. Cremation memberships are paid up after 5 Years.

SOCIETY RULES

Only one main member per Society membership and must be 18 years and maximum age 95 years.

- ID copy of main member must accompany application and full identity numbers of spouse and children.
- Although The society is assisted by reputable service providers, the Society operates on a "good faith" basis and benefits are paid out only as per funds available.
- The main members will receive monthly notices of deaths and assistance payments by the society.
- A yearly audit report will be done by the administrator and published to main members only.
- Should the need arise, premiums will be adjusted accordingly.
- Only South African citizens can join the Society.
- If memberships are in arrears of 45 days, your membership will be cancelled, and re-application with probation periods will be enforced.
- The society will not assist any member if their society membership is in arrears or in probation periods.
- Should the name, surname or identity number differ from the application for deceased assistance to that of a death certificate no assistance will be rendered to the society member.
- No person can be replaced by another once assistance has been rendered on any membership.
- If any member should defraud the society, legal steps will be taken against them.
- All complaints must be forwarded to the secretary "The Elite Friendly Society" in writing within 30 days.
- A R10 administration increase across the board irrespective of date joined will be effective every year from 1st February 2027. 10% grocery birthday benefits will increase.
- Limited number of graves can be reserved as per age group. First come first secured.
- Should family make use of own service providers, the society will not assist the family in paying any benefits out.
- Any party can cancel giving 30 days written notice.
- There is no surety or surrender values to this society membership.
- Membership fees are payable once every year for the above benefits, but main members can negotiate to pay the membership fees over a 12-month period.
- All claim correspondence will only be with the main member or their beneficiary.
- Izotsha Memorial Park rules and regulations must be always adhered to.
